Subject: Prime Minister's Internship Scheme (PMIS) providing paid internship opportunities to final year students of Graduation and Post Graduation – requesting wide outreach within University and in affiliated educational institutions – reg.

Respected

1. The Prime Minister's Internship Scheme (PMIS) is a flagship initiative of the Government of India, announced by the Hon'ble Prime Minister, Shri Narendra Modi ji, during his Independence Day address in 2024 on providing structured paid internship opportunities to the youth to enhance employability. In pursuance of PM's vision, the Hon'ble Union Minister for Finance and Corporate Affairs, Smt. Nirmala Sitharaman ji, allocated specific budgetary support for the Scheme in the Union Budget 2024–25 onwards. Phase I and Phase II of the Scheme have since been successfully implemented by the Ministry of Corporate Affairs in close coordination with the State Governments, paving the way for its further expansion.

2. The Phase III of the scheme have been commenced with a target to provide **1.10 lakh internship opportunities** in top 2000 large size companies across India by December

2026. The scheme is being implemented through a dedicated online portal and PMIS Mobile app developed and maintained by the Ministry of Corporate Affairs.

3. The Link for the dedicated portal to facilitate the candidates for Registration, internship application and further processes of the scheme is <https://pminternship.mca.gov.in/>

4. The portal is available 24X7 to all the eligible candidates for registration where they can apply upto 3 opportunities. They can also filter out their choices based on the State, Districts, Sectors and education qualification.

5. The candidate may download the **PMIS mobile app** from the Google Play Store. The Scheme is duly supported by the toll-free number **1800 11 6090** for any assistance.

Below are the basic features of this scheme which can be disseminated amongst the students:

- **Monthly financial assistance of ₹9,000**
- **One-time incidental grant of ₹6,000**, paid in two tranches through DBT
- **Life and Personal Accident Insurance coverage**
- **PMIS Certificate** upon successful completion of the internship.
- **Internship of 6 or 9 months** duration
- **Additional monetary & non-monetary benefits** like Free or subsidized food and/or accommodation and/or transport facilities being provided by many companies.

B. Eligibility Conditions for Candidates

- Youth aged **18 to 25 years** (as on the date of submission of application);
- Must be an **Indian national** and **not engaged in full-time employment**.

Educational Qualification:

- Candidates who have passed **High School / Higher Secondary School**
- ITI certificate holders / Polytechnic diploma holders;
- **Graduates** (e.g., BA, B.Sc., B.Com, BBA, BCA, B.E./B.Tech, B.Pharm, etc.)
- **Post-graduates** (e.g., MA, M.Sc., M.Com, MCA, M.Tech, etc.).

Note: **Final-year students** pursuing **full-time Graduation or Post-Graduation** are **eligible to apply** (Other candidates in full time education are not eligible). Candidates enrolled in **online or distance learning programmes** are eligible.

C. Ineligibility Criteria:

- Graduates or Post-graduates from IITs, IIMs, IISc, IISERs, National Law Universities (NLUs), NIDs, and IIITs;
- Candidates possessing professional qualifications such as CA, CMA, CS, MBA, MBBS, BDS, MD, MS, or equivalent, including M.Phil. and Ph.D.;
- Candidates **currently undergoing or who have previously completed** any skill training, apprenticeship, or internship under **any Central or State Government scheme**, including NATS or NAPS;
- Candidates whose **family income exceeds ₹12 lakh** in the preceding financial year. Family means self, spouse and parents;
- Candidates having a **family member who is a permanent or regular employee of Central or State Government, PSUs, statutory bodies, or local authorities**;
- Candidates **engaged in full-time education** (other than final-year students)

D. Request for Universities and Affiliated Institutions
